- Licensing of medical flying expert commission.








We are pleased to announce that on January 28, 2019, new edition of the International Comparative Legal Guide: Aviation Law 2019 was published.

Among the priority activities of the Institute: organization and holding of conferences, round tables, seminars and other events with the aim of promoting and developing the science of air law and space law.




Air Law Conference
